## **TRANSPORT APPLICATION & AGREEMENT**

## Terms and conditions for availing School Transport for AY 2023-24

- 1. School bus transport is provided **by** Bhavans -School Bus Transportation -Sole Proprietorship LLC in accordance with the ADEK and DOT guidelines, hereby referred as Transport Company.
- 2. Transport fees are to be paid for the full term at the beginning of each term to school and is non-refundable. A receipt will be issued for the payment made. No payments shall be made to the transport company or to the staff of the transport company. School will not be responsible for any payments made to the transport company/staff.
- 3. The bus route/s are identified and fixed considering the best interest of all students and this cannot be changed. Those parents who are willing to accept the routes finalized by the transporter only need to opt for the school transport.
- 4. Students should be ready at their respective pickup points 5 minutes before the pickup time allotted by the school. Bus will not wait for more than two minutes. The timings will be shared to all parents.
- 5. The travelling time of bus is fixed as per the DOT guidelines and will not exceed one hour, one side. Those parents who are willing to accept the total travel time of one hour irrespective of their locations only need to opt for the school transport.
- 6. The policy followed will be children picked up first at morning will be dropped off first at evening except for the locations—Barai and Bawadi.
- 7. Students from Barari and Bawadi will be picked up first and dropped off last, due the constraints in total travel time for this particular route/s.
- 8. Requests for change in pick up and drop off timings will not be considered once the transport service is agreed for.
- 9. Minimum one week notification is required for change in location.
- 10. Children of Grade 6 and below will not be left at the drop off point unless the designated adult is present to collect them. If not, the child shall be brought back to school, and it will be the responsibility of parent to come and collect the child from school.
- 11. Transport application/s received after the cut-off date communicated, will not be considered.
- 12. Parents who agree to the above-mentioned points can opt for school transport.
